Telluride, CO: January 8-13, 2023

(5 nights/4 ski days). **We need one more Lady!** Lodging will be **The Peaks Resort**, ski-in/ski-out, in Mountain Village. For those who stayed there last year, remember how nice it was to have your boots warmed overnight and skis laid out for you in the morning! There are many good restaurants a short walk away in Mountain Village, and you can take the gondola down to Telluride for more choices. The rooms are all double occupancy, but couples may prefer one King bed at \$1,195 pp as opposed to 2 King beds at \$1,255 pp. The contract includes bus transportation, porter from bus to lobby, ski valet, accommodation, and daily breakfast. For you Black Diamond skiers Telluride is putting in a new number 9 Plunge Lift.

The bus will be departing at 6am on Jan 8 from the parking lot of RH Johnson Recreation Center in Sun City West, stopping in Flagstaff for lunch and Cortez for a Pitstop and snacks. We will arrive in time to get our boots and skis down to the ski valet. Check out Telluride videos on YouTube.com!

Whitefish, MT: February 5-10, 2023

(5 nights/4 ski days). **Space is still available!** Lodging is at the **Firebrand Hotel** in the heart of Whitefish. The contract guarantees 15 rooms, airport RT transfer from Kalispell (including skiers arriving on different flights), porter from bus to lobby, 4-day lift ticket, Welcome Wine and Cheese, private shuttle to ski area and 5-day breakfast including tax and tip. The single supplement is an additional \$499. The price for the land portion is \$975 plus the air portion of \$581 equals \$1,556 for all traveling with us from Phoenix. The ski area does not use EPIC or IKON so the discount for non-skiers is \$260, seniors 65-69 \$20 and seniors over 70 \$160. Please be sure we have your official name for the airline and your KTN number if you have one. **You have until December 4**th **to sign up for Whitefish.**

Winter Park, CO: March 5-10, 2023

(5 nights/4 ski days). **Space is still available!** Lodging is at the **Vintage Hotel** in studios with kitchenettes, 2 queen beds, heated outdoor pool, spa, and cabriolet to ski area. The contract includes airfare from Phoenix, accommodation, porter from bus to lobby, vouchers for breakfast and a 4-day lift ticket. The discount for non-skiers or IKON pass holders is \$289. The single supplement is an additional \$599. The cost for the land portion is \$1039. The airfare is yet to be determined. **You have until January 4th to sign up for Winter Park**. Check out the YouTube video "Introducing the 7 territories of Winter Park Resort".

CANCELLATION Policy: Please read the cancellation policy in your Hold Harmless Agreement or online at https://vsscskiclub.com/wp-content/uploads/2022/04/HHA.pdf and put the cancellation dates on your calendar. It is important that you call or email Barb Stevens if you need to cancel a trip. You will receive a full refund if cancellation is received more than 90 days before the departure date. We will start a waiting list for all trips as soon as they are full. Consider purchasing trip insurance.

Important things to remember when making payments:

- Trip Application forms must be sent along with a check for dues (\$20 per person) and trip deposit(s) if you are signing up at this time.
- The Application must be filled out COMPLETELY (both sides) and SIGNED.
- The Hold Harmless Agreement must be initialed on the front and signed on the back.
- Carefully note the dates for Balance Due and No Refund After. If you need to cancel a trip, please call the Trip Captain prior to that date.
- Please write, "Balance for XX trip(s)" on the Note line of your check.
- Make checks payable to Valley of the Sun Ski Club, or VSSC, and mail to:

Note: If you are paying dues only, please include the Dues/Trip Application with your check. Be sure to complete both sides and sign it, along with the Hold Harmless Agreement, initialed and signed.
