Altitude Sickness

Symptoms of altitude sickness may include fatigue, inability to exercise, loss of appetite, sleepiness or difficulty sleeping, nausea or vomiting, rapid breathing, shortness of breath, headache, rapid heart rate, insufficient urine production.

If you experience symptoms, stop and rest, do not go any higher in elevation for at least 24-48 hours, if you have a headache take ibuprofen, nausea take anti-nausea medication like promethazine (prescription), drink plenty of WATER, don't smoke, drink alcohol, or exercise. Please look up altitude sickness for further information.
