## Trip Reports

WHITEFISH, MT: Feb 5-10 (5 nights/4 ski days). Alaska Airlines (AS) flight 603, departs from Phoenix Sky Harbor at 11:30 am to Seattle, WA, with connection to Kalispell Glacier International Airport (AS 2331), arriving at 5:19 pm. RT shuttle service from the airport to the Fireband Hotel, in the heart of Whitefish. Included is porter service for luggage, 4-day lift tickets, a Welcome Wine and Cheese party, private shuttle to the ski resort and 5-day breakfast (including tax and tip). Return to Phoenix on the 10<sup>th</sup>, departing Kalispell on AS 2270 at 11:00 am, arriving back in Phoenix from Seattle on AS 744 by 5:30 pm.

There are 22 on the trip, including a few people from Alpine/AZ Ski joining our group. Check-in will be at the airport, day of departure. Make sure your checked luggage is tagged, and remember there will be baggage fees for checked luggage payable at check-in (both ways). We are restricted to one checked bag per person (there is an exception for those bringing skis/boots, who can also have one regular checked bag). 1st checked bag is \$30, 2nd bag is \$40. Ski bag and a boot bag are considered one piece of checked luggage. And keep the weight under 50 lbs. per bag! Your carry-on bag must fit in the overhead, and our hopper flights between Seattle and Kalispell is a smaller plane, so space will be at a premium in the overhead bins.

## Reminders

Be prepared!! Stretching, yoga, tai chi. Anything to prevent injury and be ready for the ski season.



<u>Altitude Sickness</u>-I hope those that went to Telluride fared well. Elevation in Mountain Village where we stayed is 9,547 feet. Some of us made it to a lift-served elevation of 12,515 feet!

Symptoms of altitude sickness may include fatigue, inability to exercise, loss of appetite, sleepiness or difficulty sleeping, nausea or vomiting, rapid breathing, shortness of breath, headache, rapid heart rate, insufficient urine production.

If you experience symptoms, stop and rest, do not go any higher in elevation for at least 24-48 hours, if you have a headache take ibuprofen, nausea take anti-nausea medication like promethazine (prescription), drink plenty of WATER, don't smoke, drink alcohol, or exercise. Please look up altitude sickness for further information.

## From the Treasurer

- Trip Application forms must be sent along with a check for dues (\$20 per person) and trip deposit(s) if you are signing up at this time.
- The Application must be filled out COMPLETELY (both sides) and SIGNED.
- The Hold Harmless Agreement must be initialed on the front and signed on the back.
- Carefully note the dates for Balance Due and No Refund After. If you need to cancel a trip, please call the Trip Captain prior to that date.
- Please write, "Balance for XX trip(s)" on the Note line of your check.
