Telluride, CO- We will be staying at The Peaks Resort and Spa, a club favorite ski in/ ski out Resort!! Once lodge pricing and specifics are known, we will pass them along.

Snowmass, CO- We will be staying at Stonebridge Inn. Lodging, plus breakfast is \$1,262.00. The airfare (we fly direct from Phoenix into Aspen) is \$541.00. Resort Group lift ticket ADULT for 4 days is \$360.00 for a total of \$2,163. If you are a SENIOR (65+), your lift ticket for 4 days is \$320, for a total of \$2,123.
