History

The Sun Cities Ski Club was founded in 1979. by Miner Patton, a retired educator and certified ski instructor from New England. In 2014 the name was changed to Valley of the Sun Ski Club. It is a non-profit, tax-exempt corporation operated by a board of volunteer directors for the purpose of planning and coordinating ski trips and other social functions on behalf of its membership. The original membership consisted of 32 members, mostly from the Sun City community, who intended to ski primarily at our Arizona ski resorts. Membership grew slowly in the first few years but by 1983, membership was up to 100 and the Club was by then taking trips to Utah and Colorado. The Club has continued to grow steadily, with a current membership of about 94 members. We plan about two or three ski trips a year to the major ski resorts in Colorado, Utah, Idaho, and California. The Valley of the Sun Ski Club is open to all interested skiers. Many members are longtime skiers, but we do have beginners as well.

Meetings

Meetings are usually held the first Thursday of each month from November through April. We meet at The Foundation, Grand Canyon Room, 14465 RH Johnson Blvd in Sun City West. The Social Hour begins at 5pm - BYOB with snacks provided and is followed by a catered buffet dinner at 6pm. Reservations are required. A short informal business meeting begins at 7pm.

Ski Trips

Ski trips are arranged by Sun Trac LLC. These are full-service ski trips that include all travel and hotel accommodation. Trip Leaders arrange room assignments and itineraries. The resorts offer opportunities for a variety of ski levels, from beginner slopes to challenging black diamonds. Cross-country skiing is available as well as numerous activities such as sleigh rides, group dinners, shopping, hiking, etc. Spouses and friends who don't ski are welcome. Trip prices have ranged in the past from \$900-\$1,800 per person for travel and hotels depending upon the type of travel (i.e., bus/air) and location. Lift tickets and meals are additional.

Dinner Reservations
