<u>Telluride, CO</u>: January 26th – 31st, 2025 Traveling via MOTORCOACH.

URGENT: We need to fill the bus to Telluride. ASAP!! We have 17 spaces to fill.

Traveling via MOTORCOACH to our favorite hotel in Telluride. The Telluride Hotel is a boutique hotel with a lovely lobby filled with stuffed chairs and couches to gather near the fireplace. Rooms have a small refrigerator, microwave, and a coffee brewer. There is a small restaurant near the lobby serving breakfast 7am – 10 am, Après ski 4pm – 5pm, and dinner 5pm – 10pm. The hotel stores our skis in the lobby and has a shuttle to take you to the gondola, which goes to the slopes OR Lift 7 which is just a few blocks away. The hotel shuttle will take you to dinner downtown or you can walk to the corner and catch the Galloping Goose, which circles the town. There is also a grocery store, Clarks Market, just a block away.

We will fly directly to Aspen on American Airlines. Depart Phoenix February 23rd 9:30 am on flight #6686 and arrive in Aspen at 11:29am.

We will shuttle to The Stonebridge Hotel. The Stonebridge is a smaller hotel but has a bar with tables to gather for a beverage, lunch or dinner. The hotel is undergoing renovations so there will be a remodeled restaurant and bar. Rooms have a mini refrigerator and a Keurig coffee brewer. This destination is world renowned as a supreme environment for skiing on all levels. It is a quaint village with lots of restaurants and shops within walking distance of our hotel. Skiers have a short walk to the Snowmass slopes. There is a free shuttle for skiers to ski at the other three mountains (Buttermilk, Aspen Highlands, and Aspen). Don't forget to pack your swimsuit. There is a huge pool and spa area outdoors, and an inside workout room as well. Breakfast is included in the price!

The return flight #4882 depart from Aspen Friday February 28th at 12:02pm and arrive in Phoenix at 2:10pm.

Sun Trac can purchase 4-day LIFT TICKETS for \$360 for seniors 65+, and \$440 for adults, BUT WE MUST have 20 skiers to qualify for these low prices. Please let Mary Ann know if you want to purchase your lift ticket from Sun Trac ASAP! If you purchased your ticket from IKON, please give Mary Ann your ticket number so we can use it toward our required 20.

CANCELLATION Policy: Please read the cancellation policy in your Hold Harmless Agreement or online at https://vsscskiclub.com/wp-content/uploads/2022/04/HHA.pdf and put the cancellation dates on your calendar. From the Treasurer

Important things to remember when making payments:

- Trip Application forms must be sent along with a check for dues (\$20 per person) and trip deposit(s) if you are signing up at this time.
- The Application must be filled out COMPLETELY (both sides) and SIGNED.
- The Hold Harmless Agreement must be initialed on the front and signed on the back.
- Note carefully the dates for Balance Due and No Refund After. If you need to cancel a trip, please call the Trip Liaison prior to that date.
- Please write, "Balance for XX trip(s)" on the Note line of your check.
- Make checks payable to Valley of the Sun Ski Club, or VSSC, and mail to:

Note: If you are paying dues only, please include the Dues/Trip Application with your check. Be sure to complete both sides and sign it, along with the Hold Harmless Agreement, initialed and signed.

SNOWMASS: If you paid the \$150.00 deposit, your balance is \$1644.00. If you have not paid the deposit and wish to go to Snowmass, your balance will be \$1794.00.

The meeting was called to order at 6:19pm by President Umberger.

Treasurer's report - Mike Wegener

The VSSC account has a balance of \$20,572. Transportation and Hotels will need to be paid soon. There are currently 15 fully paid members and 13 with deposits only for Telluride. There are 2 fully paid and 13 with deposit only for Snowmass.

Going forward we need to decide what choices we want for dinners at our meetings. Last season we lost \$2,000 by subsidizing our catered dinners. Our **Dinner Coordinator**, Linda Norton, would like your suggestions!

The current membership is 46.

Telluride, CO- Jan 26-31, 2025

Transportation is via bus.

There will be a brief stop in Flagstaff for breakfast and another in Kayenta, CO at a grocery store to stock a few supplies during your stay. There are 10 spaces available. All of us need to promote our ski trips. Hotel Telluride is in the town and has a fireplace, lobby, restaurant and an easy walk

to other shops and restaurants. There is a shuttle that runs from 7am to midnight.

Aspen Snowmass, CO-February 23-28, 2025

Transportation is via air Phoenix to Aspen.

Lodging is at Stonebridge Inn in the village. Breakfast is included. There is a fireplace area nice for gathering, restaurant and wonderful hot tubs! Lockers for ski equipment are assigned for easy access on the ground floor and an easy walk to the slope. Group ski lift tickets may be purchased from our vendor Richard Vangelisti (Sun Trac), but we need enough people to qualify for group rates! Snowmass 4-day passes: Adults \$440, Senior+65 \$360. The tickets include all 4 mountains: Snowmass, Aspen Mtn, Aspen Highlands and Buttermilk.
